Getting to Know Adobe Bridge Adobe Bridge is browser-based. This means that the Windows or Mac version must be installed before you install the browser version. The difference between the two versions is that the Windows version runs within the Internet Explorer browser on Windows computers. The Mac version runs within Safari. The Windows version of Bridge requires Internet Explorer 7 or higher. Internet Explorer 8 is not supported. Internet Explorer 9 is not supported; the latest version supported is Internet Explorer 9. Firefox and Google Chrome are also supported, but not Firefox 3. * * * # Note Although Adobe Bridge requires Internet Explorer 7 or higher, Adobe Lightroom is designed specifically for OS X and doesn't require it. You can use Bridge to organize images in Lightroom, as well. * * * The Mac version of Bridge is designed to run only in Safari. It is very similar to the Windows version and works well on both Macs and Windows machines. You can edit color of image in Adobe Photoshop Elements using hue, saturation, and lightness option. The basic method of change color is hue (with replacement), saturation and lightness or color balance. For more details, read below. The reference of color change: However, it is not possible to change color of an image in the basic color. The following image shows that how we can change color of a selected image using the basic color option. Basically, Photoshop Elements use the basic color option to change color of an image using different hue, saturation and lightness (HSL) options. Following is the summary of this option: Hue: When you select the hue option, it will change the color of all the pixels in your image in that color. For example, to make it more vivid, it's recommended to select pure hues such as red, yellow, orange, purple, blue, green or other similar colors. When you select the option, it will change the color of all the pixels in your image in that color.
