The New West Researchers from UC Riverside are asking the state to give them more time to prove the potential links between the region's morning fog and

climate change. The National Oceanic and Atmospheric Administration launched the first of three federal grants to researchers this summer to study the environmental effects of short-term weather events. The \$1.4 million grant, awarded in June, is specifically focused on California's foggy wet season. The research is aimed at developing the tools necessary to forecast wet season fog at the beginning of each year — to give forecasters more time to prepare for the potential impacts. “If they can get the information about the climate and its variability, it will be another tool in the toolbox to help us respond to these incursions of the fog,” said Jim Hanna, a professor of hydrology and water quality at UC Riverside who is a lead researcher on the effort. The study, funded by the California Ocean Protection Council and Northern California Ocean Science Coordination Office, also hopes to better understand the relationship between the ocean and land and its impact on fog in the region. The research includes a series of coastal exercises that will help test how fog moves from land to sea. “What we’re doing is thinking about the interactions between atmosphere and surface and looking at all the different processes,” Hanna said. “It’s about

understanding the dynamics of the atmosphere and how changes in that change the whole hydro-geo-climatic system.” “There’s not been a lot of work in looking at how changes in the atmosphere affect the inversion layer in the atmosphere,” Hanna said.

“That’s what the weather forecast is, the upper-atmosphere, and they’re going to have to forecast it better.” The project will collect data from national
