Libya army commander urges UN to approve arms shipments  
Published duration 30 November 2011 image caption Muammar Gaddafi has ruled Libya since a 1969 coup The commander of Libya's national army has told the UN Security Council that he wants it to approve the supply of weapons to his troops to fight rebel-held towns. A UN diplomat said the council had decided to put a Libyan delegation on a panel to help the resolution of the conflict. Meanwhile, the US says it has approved the sale of Apache attack helicopters to Libya's government. Those deals were part of a \$570m (£332m) arrangement over the past week. Earlier this week, the US rejected a similar deal for six Apache helicopters to an EU company following concerns over what it was being paid for. UN Security Council Resolution 1973, which authorised international military action against the Gaddafi regime in Libya, does not mention weapons supplies. Resolution 1973 also calls for a ceasefire in the conflict but that has not been observed. 'Defence spending' On Tuesday, UN secretary-general Ban Ki-moon nominated a panel to review all arms deliveries that take place in Libya. In a letter addressed to the UN Security Council, Gen Adel Abdelfatah, commander of the National Army, writes: "I am surprised that you are not in the process of putting the Central Bank of Libya on the panel... [that] would ensure the defence spending and defence review of Libya... "We expect you to help and support this new panel and keep its secretariat [operations] report to you and us regularly." Mr Ban's panel was meeting for the first time on Monday. Last week, the US approved a sale of 11 Apache helicopters to Libya's government and has since sold a further six Apaches to support the other military deals. In a statement, the US State Department said the sale would help Libya build up its defence capabilities and strengthen its war-fighting capabilities. It said Washington appreciated its cooperation in the resolution of this issue, which was in the "national interest of the United States". Libya's Deputy Foreign

Minister, Abdullah al-Attiyah, said the \$570m deal was well worth it. "Gaddafi means business to stay in power for the next one, two, three, four, five, six decades," he said, citing the need for stability. "We're going to make

Wayne County General Hospital, 621 F.2d 777, 781 (6th Cir.1980). 32 For the reasons herein stated, the District Court's judgment as to the defendants Smith and Caraway is REVERSED and REMANDED for new trial; the judgment in favor of the defendant City of Memphis is AFFIRMED. 33 WELLFORD, Circuit Judge, dissenting. 34 I agree that the case should be remanded for retrial on the issue of the alleged use of excessive force by Officer Smith. I part company with the majority, however, over the propriety of giving an involuntary manslaughter instruction. 35 The trial record does not present even a scintilla of evidence, direct or circumstantial, which, if believed by the jury, would warrant a conviction of involuntary manslaughter. 36 Instruction F-3 was derived from Williams v.
